#### Preliminary Inquiry & Technical Meeting (if any)

Mandatory attendance is required for both players of the team for the Preliminary Inquiry & Technical Meeting (if any). The detailed schedule is as follows:

The access to the location of Preliminary Inquiry will be controlled to avoid mass gathering.

Players and Delegation members are required to attend the Preliminary Inquiry and present their passports, accessories and a certificate of COVID-19 fully vaccination issued by the relevant competent authorities, or a COVID-19 PCR printed test result issued by an authorised health laboratories no earlier than three days before arrival. Failure to provide these documents will entail a disqualification of the team concerned.

All players wishing to take part to a VW Beach Pro Tour Futures Event must fully comply with the requirements set by the CEV/FIVB regulatory framework.

The awarding of the FIVB World Ranking points will be applied for this event as per the FIVB Beach Volleyball Sport Operations Manual, in case a fair access to all eligible and registered to participate athletes is ensured and will be confirmed after the issuing of the confirmed lists.

### Uniform and Accessories:

The playing tops/tanks will be provided by the organiser for all Main Draw and Qualification players. Shorts/bottoms and accessories must be provided by the players and/or by their sponsors.

If required by the Technical Delegate, other uniforms and accessories will be checked during the Preliminary Inquiry. Athletes of the same team must wear the same colour and style of shorts.

The display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.
